Mayor Holland expressed her appreciation to city workers; volunteers and other area public works crews who helped clear storm damage after the high winds. The workers worked together to the benefit of the citizens.

Vice Mayor Hale said he heard plenty of good comments about the city's public safety and public works departments along with the Carroll County Electric Dept.

Councilperson Barksdale said the personnel worked very professionally in serving the public's needs.

Councilperson Glisson said the city has some outstanding people in public safety who leave their homes and families to serve others.

Councilperson Lankford said the city has begun training of coaches in the Champions of Character program. Greg Barker is in charge of the program.

Councilperson Broadbent said the water department repaired a well near J & J Auto Racing. The storm knocked out some of the monitoring equipment causing an employee to monitor water levels every two hours during the night to assure compliance with state regulations. She also encouraged the city to never remove
