Ms. Tracy Prestwood with Computer Mechanix in downtown McKenzie asked the city to consider a 30 minute parking limit or courtesy signs indicating a time limit on Cedar Street in front of Super Drugs, Computer Mechanix, New to You Resale and Heartworks. All the store owners concurred with the request as many of businesses have short term visits by their customers. She expressed concern with T-Birds restaurant opening as it will additionally limit parking downtown.

Councilperson Townes reported on the performance of the street department.

Mayor Holland reported that a community group around Mulberry Park has organized and hopes the city and community can develop the park and improve its sports activities. Soon new improvements such as a new pavilion, grills and safety barriers will be added to the park. A meeting of the area citizens convened at Greater Enon Baptist Church on Thursday at 5:30 p.m. to discuss the plans for Mulberry. A local citizen will also paint murals on the outsides of the restrooms to enhance the park.

Bethel University presented Police Chief Moates, Lt. Ricky Sawyers, Sgt Kim Barker, Sgt Ryan White and Carol Barker with certificates for their assistance in helping manage traffic and security during the Tennessee Supreme Court's session at Bethel University.

City Recorder Charlie Beal told the council the sidewalk project on Walnut is underway on the Webb School side of Walnut. Once this project is completed, the construction crews will begin work on the other side of Walnut.
