Councilperson Davis asked if the organization was in Huntingdon or McKenzie and he was advised by Attorney Jones that the organization is in Huntingdon across the rail tracks from E.W. James. Councilperson Davis asked that under the current tax relief plan, does the state send to the city/county the difference in tax relief and taxes owed and the answer was yes to that question.

## j. Council Discussion/Reports

Mayor Winchester advised the council that the library was having an open house on April 11, 2007 from 2:00 to 4:00 p.m. and everyone was invited. Winchester complimented Mrs. Wilson on the good appearance of the building, the modernization of the items available to patrons and encouraged the council to support the library on this open house date.

Winchester also advised that at the working session held on March 19, 2007 on the subject of the property tax, in clarifying a statement about freezing taxes when a property owner reaches 65 years of age, their property tax would be frozen at that level. If that property was sold, transferred, etc, it would go back on the tax rolls at the proper tax level. The Mayor had made a statement that 90% of the taxpayers would be frozen and this is true but only when they reach 65 years of age and their income level is at the set amount (i.e. \$20,000, \$30,000, \$60,000.) As reminded by Councilperson Ramey, the county and local governments would be required to pass legislation to approve the tax freeze for this age and income limit.

Councilperson Hale stated that "911 equipment distribution" was on hold at the present time but Chief Cooper advised Council that he believed most of the details had been worked out and the county was waiting to hear from the towns to go forward.
