Non-Agenda Item Request

Mayor Winchester requested permission for a non-agenda item. Motion was made by Councilperson Hale and seconded by Councilperson Allen. Motion was approved by voice vote. Mayor Winchester advised that the 1969 Howe fire truck that had dropped a drive/transmission shaft that also operated a pump on the truck had been towed to Memphis and the repair shop was having difficulty finding spare parts for the drive/transmission shaft and that the pump had earlier failed the standard pump test. He advised that Fire Chief Tucker had been advised to look for a possible replacement apparatus and had located a 1988 Peirce Rescue/Pumper in Pennsylvania on auction. Mayor Winchester had given permission to bid on the vehicle not to exceed \$20,000. The bid from McKenzie was accepted for \$18,500 plus service fee totaling \$20,025.00. If approved this vehicle would replace 2 vehicles when all equipment was moved and swapped out and the red Bronco would be available for sale or use in another department. The Fire Department had recently removed the "Chief's car" from the fleet and the proposed vehicle would seat 9 people with breathing gear on so only one vehicle would be dispatched to some local fire.

A motion was made by Councilperson Davis, seconded by Councilperson Holland to proceed with purchase of the vehicle. Arrangements for getting the vehicle to McKenzie will be made when the auction purchase is approved. Transfer will probably be by freight truck.

Parks and Recreation Advisory Board Chairperson Broadbent had attended the Tennessee Parks and Recreation Association meeting in Gatlinburg at her own expense and she was asked to talk about the meeting. Broadbent presented a fact sheet to the council from what she had observed and participated

in at the conference and the fact sheet is included with the minutes of this meeting for record.

k. Any Other Business

Mayor Winchester advised that Councilperson Adkins was in the hospital with a broken leg after recovering from pneumonia and Councilperson Ramey was scheduled for bladder surgery on December 21, 2007 and he asked the council to keep these members in their thoughts.

Councilperson Davis stated that the city should be proud of the accomplishments of the McKenzie High School Rebels football team that finished second in the State 1A tournament. Mayor Winchester advised he would be presenting the Zenith Award to the football team at the football banquet in January.

l. Adjournment

With no further business, motion was made by Councilperson Holland, seconded by Councilperson Hale to adjourn. The motion was approved.
