K. Department Head Reports:

Fire Chief Brian Tucker reported the last department had worked a total of 33 incidents. 9 of those were commercial alarms, 8 aircraft stand byes, 5 for both EMS Assist & motor vehicle accident and various others.

Water Superintendent Billy Wood stated his department was staying busy fixing leaks and taking care of the city's water.

Police Chief White stated that his department had answered 984 calls for the month, 348 were for Security checks – Home/Business/Parks, 197 for vehicle stops, 75 citizens assist, 57 for investigations 10-43 and numerous other calls.

Superintendent Johnny Mercer with Public Works said they were servicing equipment, busy running the brush truck, picking up leaves and doing household pickup this week.

Philip Morrisett for the Codes Department reported working on the condemnation of two houses and just trying to keep the city clean.

Parks Director Billy Hollowell stated that TWRA had stocked the pond with 500 trout. They had finished with getting all the Christmas decorations up in the downtown. He said the concrete slab on the pickle ball court was complete. It will be late spring before the court is finally complete. He is working on bids for fencing and lights at the ball park.

L. Council Reports:

Councilperson Pruneau inquired if any of the other council members had received information discussing things across the State via zoom. Most seemed to have gotten the info. Mayor Griffin had not received the information from TML due to just being elected and TML not having his contact information.
