#### I. New Business:

a. Bid opening for Fire Department Turnout Gear

# N. Department Head Reports:

Fire Chief Brian Tucker reported it had been a slow month, with 8 commercial alarms, 2 EMS, and several other incidents. There was only one large residential fire. They were still about 2/3 of the way through checking fire hydrants due to doing several other jobs for the city. Chief Tucker was happy to say they had pulled in about 321 fire contracts, resulting in \$32,100.00 towards the new fire trucks.

Water Superintendent Billy Wood was absent.

Police Chief Moates introduced Lt. Ryan White as the new Assistant Police Chief. Chief Moates stated that his department had answered 1,010 calls for the month. 375 were for Security checks – Home/Business/Parks, 163 for vehicle stops, 78 citizens assist, and numerous other calls.

Superintendent Johnny Mercer with Public Works stated they were staying busy with right of way mowing and getting the leaf truck ready for fall. He also mentioned they had laid close to 200' of sidewalks within the last couple of weeks and were still staying busy mowing yards turned in from the codes department.

Philip Morrissett for the Codes Department was absent.

Parks Director Billy Hollowell stated they were about caught up with summer mowing and trimming. He also mentioned even though middle school softball was finishing up next week, city league soccer would be starting on Saturday.

## O. Council Reports:

Motion carried.

Mayor Holland stated that the Sweet Tea was successful due to how all the city departments all pulled together to help. The heat seemed to be more this year than in the past, but it is difficult to choose a date because of all the other festivals in the area. She reminded the council that on Thursday, the 15<sup>th</sup> we would be having a city-wide event to thank industries, businesses, clubs and city department in our success in winning the Small City Progress award. At this event, we will also recognize three business owners who are retiring with more than 137 years of business in our community.
